## Appendix A COVID-19 – Adaptations to Behaviour Policy



In light of the need for children to behave differently when they return to school, some adaptations have been made to our Behaviour Policy.

At Russell Hall Primary we have 3 School Rules; Be Safe, Be Ready, Be Respectful. Appendix B details some specific rules regarding COVID-19 and how they relate to each of our rules.

## **Positive Reinforcement**

It is always our Policy at Russell Hall to reinforce correct behaviour and good choices with positive verbal praise and our class dojo rewards system. This will continue and will be used to reinforce changes to the way we need to behave, such as:

- Following new routines for arrival and departure to/from school
- Adhering to instructions on hygiene, such as handwashing and sanitising
- Following routines and instructions on how/where to socialise in school
- Moving around school as per instructions, e.g. one-way systems and 'out of bounds' areas
- Following instructions for coughs and sneezes and adopting a 'catch it, bin it, kill it' routine
- Telling an adult if you or a member of your household experiences symptoms of COVID-19
- Following rules about not sharing equipment and looking after your own allocated equipment
- Following instructions about use of toilets and communal areas in school

## Consequences

In these very difficult times, where safety is paramount, some changes have been made to the way we deal with poor choices and negative behaviour.

Some behaviour concerns referred to in this addendum may have previously been deemed less serious, however; if an action now results in the potential compromising of a person's ability to socially distance and stay safe it will now be treated in a more serious manner, appropriate to the age of the child and their understanding.

This addendum also applies to children with Special Educational Needs, whose specific needs may result in them finding it more difficult to socially distance or self-regulate. Staff will adhere to social distancing guidelines and will avoid use of positive physical restraint using Team Teach training, unless preventing immediate danger or if it forms part of an individual risk assessment.

The table below details specific concerns regarding safety and how they will be addressed:

\* Deliberate refers to an act of defiance where it is clear that the child understands the rules and chooses not to follow them.

The behaviours in this addendum are not exhaustive and at all times the Head Teacher's discretion will be used to ensure that the safety of everyone is maintained.
